## URBAN PROGRAMMING FOR INDIGENOUS PEOPLES – ORGANIZATIONAL CAPACITY STREAM FUNDING 12 MONTH ALLOCATION SUMMARY

The Alberta Native Friendship Centres Association's (ANFCA) 21 member Friendship Centres were provided annual funding for the period of April 1, 2018 to March 31, 2019 under the Urban Programming for Indigenous Peoples Organizational Capacity (UPIP-OC) stream of funding. Funding to each Friendship Centre was based upon the amount of funds received by the ANFCA from the National Association of Friendship Centres (NAFC); Friendship Centres were provided an UPIP-OC allocation in proportion to amounts received under the Community Capacity Supports (CCS) program 2014-15 fiscal year.
